Jeff Kessinger gave the Public Works and Police report. The water and sewer usage was at an average usage. Replaced water meter at 401 E. A St. IEPA Inspection performed on 2/28/18 and found a few issues and will send a letter of recommendations. The police 29 building checks, 4 complaints and 1 special detail. Tena Anseeuw made a motion to accept the Public Works and Police report and Mike Petrovich seconded it. The motion carried with all ayes.

Liquor Commission Report: Discussed the Oxford Appreciation Day. The Legion applied for a special event. Dennis Shannon made a motion to accept the C Retail Special Event for Oxford Appreciation Day on April 14<sup>th</sup> and Alan Wendt seconded it. The motion carried with all ayes.

Streets/Alleys: Water/Sewer needs to meet end of this month or beginning of next to work on budget for 18-19.

Community Development: ACT Meeting is March 12<sup>th</sup>. Working on Thrifty on 150. Will call to check on status of new Recycling Bin.

In Old Business: A Public Safety Handout was passed around and discussed. A resolve to support the Public Safety Tax was made by Dennis Shannon and seconded by Tena Anseeuw.
