PACKET PICK-UP & REGISTRATION – Packet Pick-up/Race Day Registration will begin at 6:45 a.m. at Alpha United Methodist Church. Registration ends promptly at 7:45 a.m.!

COURSE – **5K** is partially in town and partially out in the country east of town on a blacktop course. Timers at mile markers and water stops will be provided. **Family Fun Run** will start at the same location, but will be a short, closed course around a few blocks in town.

- The Top 3 Finishers in 5K in each age group listed below:

5K – 9 & under, 10-14, 15-19, 20-24, 25-29, 30-34, 35-39, 40-44, 45-49, 50-54, 55-59, 60-64, 65-69, 70 - over.
